IMPORTANT INFORMATION

Incomplete applications will not be accepted.

Baruch College cannot guarantee that requested courses will be available at your appointed registration time. The college does not override closed courses.

Students must maintain an average of 3.0 in order to continue at Baruch College.

Registration as a non-degree student is limited to 9000-level courses.

Please note the following:

- The Office of the Registrar will send a confirmation e-mail with registration instructions.
- Baruch students have registration priority over Visiting Permit students.
- New York State Law requires all college students to document their immunization. Students who fail to provide such documentation may not register for classes.

Marxe Alumni / Non-CUNY Visiting Graduate Students / Non-Matriculated Students

The Marxe School accepts Visiting Students who wish to take up to a maximum of 6 graduate credits (2 graduate courses) on a space available basis, provided prerequisites are met for the particular course.

File this application if:

- You are a returning Marxe Alum and would like to take up to 2 graduate classes (6 credits) at the Marxe School.
- You are currently a graduate student at a non-CUNY college/university and would like to take up to 2 graduate classes (6 credits) at the Marxe School.
- You are interested in taking up to 2 graduate classes (6 credits) at the Marxe School as a non-matriculated student.

Non-CUNY students and Non-Matriculated students must submit a transcript from your current graduate institution, or a prior under-grad/graduate degree showing a minimum cumulative GPA of 3.0 along with this application.

File this application if:

- Eligible to take graduate courses on a space available basis provided prerequisites are met. (Maximum 12 cumulative credits)
- Please note that the MA in Mental Health Counseling and MS in Financial Engineering programs do not accept visiting students.

WEISSMAN SCHOOL OF ARTS & SCIENCES NON-CUNY VISITING GRADUATE STUDENTS

File this application if:

- You are currently enrolled in a graduate program.
- Eligible to take graduate courses on a space available basis (Maximum 6 cumulative credits)
- Permit students are allowed to take only courses offered by the Weissman School of Arts and Sciences during their academic years as a visiting permit student.
- Please note that the MA in Mental Health Counseling and MS in Financial Engineering programs do not accept visiting students.

Please submit the following documents along with the application:

- A letter from your home college on official college which indicates you have a minimum 3.0 GPA; specifies the courses you wish to take; and confirms that the courses requested are being applied toward your degree requirements.
- Current (Official/Unofficial) graduate school transcript to help us verify prerequisites.

File this application if:

- Eligible to take graduate business courses on a space available basis provided prerequisites are met. (Maximum 12 cumulative credits)
- Non-matriculated students are not allowed to take any Accountancy or Taxation courses.

ZICKLIN SCHOOL OF BUSINESS NON-CUNY VISITING GRADUATE STUDENTS

File this application if:

- You are currently enrolled in a graduate business or related program.
- Eligible to take graduate business courses on a space available basis (Maximum 12 cumulative credits)
- Permit students are allowed to take only three courses offered by the Zicklin School of Business during their academic years as a visiting permit student.

- A letter from your home college on official college which indicates you have a minimum 3.0 GPA; specifies the courses you wish to take; and confirms that the courses requested are being applied toward your degree requirements.
- Current (Official/Unofficial) graduate school transcript to help us verify prerequisites.
